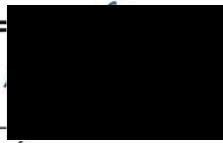

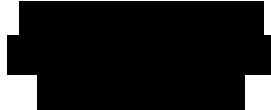

Parkland is the safety net health system for Dallas County and includes an 860 bed hospital with specialty clinics and a network of 12 community oriented primary care clinics providing over 1 million clinic visits annually. Roughly one half of the patients served are uninsured and 30% are covered by Medicaid.

Responsibilities

- Represent the School of Medicine in negotiations involving the clinical activities (clinical services, educational activity, and clinical research) of faculty, residents, and students with other health care providers.
- Advise the Dean on contractual and fiscal issues related to LSU's clinical practice.
- Provide education for faculty, residents, and students regarding health care systems and health systems financing including teaching the course "Principles of Healthcare Quality" in the LSU School of Public Health.

2007- 2012 **Louisiana State University System**
Vice President for Health Affairs and Medical Education

System includes Health Sciences Center in New Orleans, Health Sciences Center in Shreveport, and the Health Care Services Division (HCSO) which collectively encompassed 9 schools; 10 hospitals and associated clinics; 1,110 staffed beds; 2 million outpatient visits; 400,000 emergency department encounters; 260,000 inpatient days; budget of \$2 billion; and 14,000 employees.

Responsibilities

Develop strategy and direct the coordination of clinical, teaching, and research functions across the enterprise. Reported to LSU System President. Supervised CEO of HCSD and system level Assistant Vice President, CFO, CIO, Assistant VP for External Affairs, and Director of Policy & Planning. Coordinated with Chancellors of Health Sciences Centers.

Accomplishments

- Led the development of the business plan and a new private, LSU-affiliated corporate governance structure for the \$1.2 billion academic medical center in New Orleans to replace Charity Hospital that was destroyed by Hurricane Katrina.
- Developed the model and led negotiations with Our Lady of the Lake Medical Center (LOL), the largest private hospital in the state, to achieve a public-private partnership for the relocation of inpatient services and Graduate Medical Education (GME) programs from an aging LSU medical center in Baton Rouge. Highlights include over \$130 million in new construction and expansion of services and training programs.
- Directed the strategic planning and implementation of a \$120 million statewide electronic health record for LSU hospitals and affiliated clinics.
- Conceived of and led the implementation of Improving Clinical Outcomes Network (www.lsuicon.org), a network of clinicians and researchers from across the health sciences centers and LSU's Pennington Biomedical Research Institute designed to accelerate the pace of quality improvement efforts across the delivery system.
- Directed the financial turnaround of the Interim New Orleans Hospital (Charity Hospital replacement) following Hurricane Katrina. Changes resulted in \$70 million annual savings with no reduction in clinical services. Coordination of efforts across the entire system led to an additional \$30 million in annual savings.
- Implemented system-wide operational benchmarking using University Health Consortium comparative data resulting in significant improvements in efficiency; 8 of 10 system hospitals operated at 25th percentile of peers for cost per adjusted bed day.
- Proposed reimbursement model to the state Medicaid agency allowing the system to offset \$90 million loss resulting from a change in federal rules in the Disproportionate Share Hospital Program. Directed system participation in the state's new supplemental Medicaid payment program creating an additional \$40 million savings in 2012.

2004- 2007 **Louisiana Department of Health and Hospitals
Secretary**

Responsibilities

Supervision of Louisiana Medicaid, Office of Public Health, Office of Mental Health, Office of Citizens with Developmental Disabilities, and Office of Additive Disorders. Agency budget at the time was \$6.4 billion; 12,000 employees.

Accomplishments

- Led state efforts to reestablish health care for citizens following Hurricane Katrina in 2005. Negotiated a "Katrina waiver" with Centers for Medicare and Medicaid Services (CMS) to ensure reimbursement of out of state providers for displaced Louisiana Medicaid recipients and to temporarily expand coverage of residents with flexible and enhanced Medicaid reimbursement to Louisiana providers in the

immediate aftermath. Testified before Congress on three occasions related to health care recovery in order to identify priorities for federal support.

- Established a quality improvement emphasis within Medicaid and program offices, including initiating incentive programs for achieving quality standards. Improved childhood immunization rates from 49th to 6th nationally.
- Combined clinical and managerial experience to improve quality and lower costs in a number of programs: restructured Mental Health Rehabilitation (\$20 million annual savings), Early Steps (\$8 million), DME reimbursement (\$5 million), and pharmacy program changes (\$25 million).
- Led the development of a state 1115 Medicaid waiver and negotiations of terms and conditions with CMS. Waiver was subsequently withdrawn due to major landscape change following Hurricane Katrina.

1991-2004 **Louisiana State University Medical Center, New Orleans**

During this time period, the Louisiana State University Medical Center (since renamed, "Louisiana State University Health Sciences Center - New Orleans") had responsibility for the School of Medicine as well as 9 public hospitals and associated clinics (the LSU Health Care Services Division) across the state, one of which is Earl K. Long Medical Center. Responsibilities during this period included a number of different positions with increasing levels of scope and accountability. The positions and descriptions are listed below.

Responsibilities

LSU-operated public hospital which supported 10 residency training programs (2 free - standing). At the time it had 157 licensed beds; 6, 500 admissions; 41,000 inpatient days; 125,000 outpatient visits; 44,000 emergency department encounters; budget of \$84 million; and 828 employees.

Accomplishments

- Developed the plan to accept the donation of a 43,000 square foot private clinic into a newly created (for that purpose) LSU-affiliated foundation. Invested \$3 million in upgrades paid for by savings from terminating less desirable leased space. Costs savings realized after 7 years.
- Established offsite teaching clinics for more accessible care and diverse training experience.
- Directed workforce reduction of over 70 positions while sustaining clinical services as a result of state budget cuts.

1996-2003 **Earl K. Long Medical Center, Baton Rouge, Louisiana
Medical Director**

Accomplishments

- Developed chronic disease management programs with an emphasis on improving clinical quality.
- Directed clinical programs including strategic planning for services and GME, hiring physicians, management of physicians' contracts, and management of the LSU Physician Practice Plan in Baton Rouge.

- Designated Institutional Office for GME to ensure appropriate institutional support of graduate and undergraduate training programs.

1997-1999 **Louisiana State University Medical Center, Health Care Services Division
Medical Director**

Responsibilities

In 1997, the Louisiana State Legislature passed a law transferring the management of the statewide public hospital system to LSU under the LSU Health Care Services Division (HCSD) which included 9 public hospitals and associated clinics throughout the state. At the time the system had 1,400 staffed beds; 78,000 admissions; 1.6 million outpatient visits including 550,000 emergency department visits; 1,600 residents and fellows; and budget of \$792 million.

Accomplishments

- Implemented a system-wide disease management program including programs with evidence-based guidelines and metrics for heart failure, diabetes, asthma, and HIV.
- Directed the development of electronic database to support development of clinical performance measures and easier extraction of standardized performance data.
- In conjunction with pharmacists, developed the indigent patient pharmacy program that delivered over \$35 million in free drugs annually to low income uninsured individuals with chronic diseases.
- Principal investigator on Agency for Healthcare Research and Quality (AHRQ) – sponsored Building Research Infrastructure and Capacity grant aimed at developing collaborative clinical research throughout HCSD.

1991-1997 **Earl K. Long Internal Medicine Residency Program, Baton Rouge, Louisiana
Assistant Program Director and Clinical Faculty**

Accomplishments

- Worked in conjunction with Program Director to establish a new LSU Internal Medicine Residency Program in Baton Rouge.
- The program is consistently ranked as the best clinical rotation by LSU medical students. Board passage rate among graduates is consistently among top in the nation.
- Selected by senior class as the outstanding faculty member in 1992 and selected by graduating classes of 1994 through 1997 to present hoods at commencement.
