**Patient Advocacy Appointments:**

**January 2019 – Present: Family Advocacy Committee, National Foundation for Ectodermal Dysplasias (NFED):** Currently serving in a volunteer capacity as Co-Chair of the NFED's 9-person committee charged with building grassroots, organizational, and federal support for a solution to the issues families face when trying to get health claims approved for medically-necessary treatments of ectodermal dysplasia and other congenital anomalies. Maintains contact with over 5,000 NFED families nationwide and 46 professional organizations regarding the Ensuring Lasting Smiles Act. Traveled to and conducted more than 60 meetings with federal legislators and their staff on Capitol Hill.

**November 2017 – January 2019: Virginia State Lead for Advocacy, NFED:** As a volunteer, responsible for creating and disseminating emails, social media posts, and other literature for approximately 150 families in Virginia in an effort to update them on the NFED's advocacy efforts and to help families navigate state laws related to congenital anomalies and their health insurance policies.
