**SUBJECT: Subcommittee Hearing on “Investing in Public Health: Legislation to Support Patients, Workers, and Research”**

The Subcommittee on Health of the Committee on Energy and Commerce will hold a hybrid hearing that includes both in-person and remote attendance on **Wednesday, June 29, 2022, at 11 a.m. (EDT)**. The hearing is entitled, “Investing in Public Health: Legislation to Support Patients, Workers, and Research.” Witnesses will be by invitation only.

This hearing will take place in the John D. Dingell Room, 2123 of the Rayburn House Office Building, as well as remotely using Cisco WebEx online video conferencing. Members will receive WebEx participant access information by email before the hearing. No staff from member offices will be allowed in the Committee room. **However, one staffer from each member’s office may join the hearing remotely as an attendee.** Each designated staff attendee must **register** at the provided link **by no later than Tuesday, June 28, 2022, at 12 p.m. (EDT)**. For members planning to attend in person, the Committee notes that this hearing is being held during the COVID-19 pandemic, therefore the Committee will adhere to the greatest extent possible to the safety guidelines issued by the Centers for Disease Control and Prevention and the Attending Physician of the Capitol.
