1 Ms. Schakowsky. Subcommittee will come to order. As our --
2 as my ranking member just pointed out, this is our first markup
3 of the session, and I will begin by recognizing myself for five
4 minutes.

5 So under -- in today's world, unfortunately, too many
6 Americans are skeptical that government does much of any good
7 for them. That is not true of today and it's not true here.

8 It is really humbling to chair the subcommittee as we mark
9 up six bipartisan bills that will actually save lives. Think
10 about it for a moment.

11 Our committee is going to be ensuring that no more children
12 -- we hope no more -- die from dressers that tip over and crush
13 them; no more babies will suffer from crib suffocation from crib
14 bumpers; no more people are burnt from unsafe fuel containers;
15 families are safe from carbon monoxide poisoning in their homes
16 and firefighters are safe from chemicals that can actually
17 exacerbate fires.

18 This is the stuff of everyday life and I am proud to be the
19 lead sponsor of two of those bills and co-sponsor of all six.

20 I want to thank my colleagues on both sides of the aisle for
21 their leadership on these important pieces of legislation.

22 I also want to say a special thank you to all the staff on
23 both sides of the aisle for the good work that they have done
24 and that we have all done together.

1 Mike Thompson and David Joyce, a Democrat and Republican,
2 who do not serve on this committee, introduced the Portable Fuel
3 Safety -- Container Safety Act, which would direct the Consumer
4 Product Safety Commission to establish a mandatory standard for
5 flame mitigation devices in portable fuel containers.

6 The first bill we will be marking up is the STURDY Act, which
7 would direct the CPSC to enact a mandatory standard to prevent
8 furniture tip overs.

9 Every hour of every day, common pieces of furniture like
10 clothing storage units, dressers, and chests tip, tilt, and fall.

11 According to the CPSC, tip overs inflict around three injuries
12 per hour and cause, unfortunately, hundreds of avoidable child
13 fatalities.

14 Product experts and parental groups agree that tip over
15 injuries are preventable. But current industry standards are
16 simply not enough.

17 In 2018 alone, over 2 million units of children's products
18 faced recall and nursery furniture was among the leading category.

19 CPSC rulemaking can move -- can't move fast enough and in the
20 last 10 years the CPSC finalized only one mandatory safety
21 standard.

22 So I am so appreciative of Ranking Member Cathy Rodgers for
23 her commitment to working with me on this legislation.

24 The second bill introduced -- was introduced last month with

1 my friend from Chicago, Bobby Rush, and Robin Kelly is the Safe
2 Cribs Act, which would ban crib bumpers. The American Academy
3 of Pediatrics' safe sleep recommendations call for infants to
4 sleep on a firm flat surface and does not recommend the use of
5 crib bumpers due to the risk of suffocation.

6 CPSC, for its part, has been working on safety standards
7 for crib bumpers since 2012. But it is not clear when, if ever,
8 they will adopt a standard and families need this legislation
9 now.

10 And, finally, I want to take a moment to make a note about
11 -- to make note of H.R. 3169, the FASTER Act, which is designed
12 and aiming at speeding up recall of products, which I think is,
13 clearly, needed.

14 But I do want to say that this bill is not being marked up
15 this morning but was included in legislation that we heard last
16 month. We have been working in a bipartisan good faith
17 discussions on the bills that are under consideration today and
18 will continue to do so, including the working on H.R. 3169, the
19 FASTER Act.

20 We are working to ensure that the fast track recall program
21 does not lose support to ensure that consumers get recall
22 information and quick -- as quickly and as efficiently as
23 possible.

24 And I want to assure my ranking member that I am absolutely

1 committed to continuing to work together with her and all members
2 of the committee on both sides of the aisle so that this issue
3 can move forward and will move forward.

4 And so the chair now recognizes Mrs. Rodgers, ranking member,
5 for the Subcommittee on Consumer Protection and Commerce for five
6 minutes for her opening statement.

7 Mrs. Rodgers. Good morning. Thank you, Madam Chairwoman,
8 and to all my colleagues on the committee, I am pleased to be
9 here today and want to thank the chair and all the members and
10 the staff too for working in addressing many of the concerns that

22 We must work on the FASTER Act because consumer safety and
23 people's lives are on the line.

1 recall program is too slow. Yes, there was a time when it worked
2 consistently. There was a time when it was award winning.

3 But that's not the case anymore. Like many things in
4 Washington, D.C., fast track has become slow because of an
5 outdated bureaucracy -- the program from 1995 that isn't
6 functioning in the 21st century economy. Time to speed the recall
7 process up again.

8 Thank you especially to Representative Soto for working with
9 me to do just that.

10 Turning to the six bills before us today, beginning with
11 H.R. 2211, the STURDY Act, thank you, Chairwoman, for listening
12 to our feedback.

13 I am encouraged by the improvements that have been made on
14 the bill and I hope that our work will continue as we get closer
15 to a full committee markup.

16 H.R. 3172, the Safe Sleep Act, addressing a suffocating
17 hazard related to recent recalls of several inclined sleep
18 products. Losing a baby is an unimaginable tragedy and I hope
19 that our efforts here today and the work that's already been done
20 by the CPSC can help prevent these tragic deaths from happening
21 in the future.

22 I encourage parents to visit saferproducts.gov to get the
23 most updated information about these recalls.

1 suffocation hazard created by padded crib bumpers. During the
2 legislative hearing a few weeks ago, we presented data on why
3 mesh bumpers were safe alternatives. It would also prevent kids'
4 arms and legs from getting trapped in cribs.

5 I appreciate that the majority took this into account so
6 that we can consider my amendment that models what states are
7 doing. This amendment will ensure parents can access safe mesh
8 bumpers and won't turn to putting pillows and blankets back in
9 the cribs which also pose suffocation risk like padded bumpers.

10 I'd like to thank Mr. Carter and Mr. Upton for their work
11 on H.R. 1618, the Nicholas and Zachary Burt Carbon Monoxide
12 Poisoning Prevention Act of 2019. Carbon monoxide detectors save
13 lives.

14 Just earlier this year, a detector saved a Spokane Valley
15 man's life in my district, alerting him to a significant carbon
16 monoxide leak in his home, just 11 days after he had put it in.

17 I look forward to continuing to work with you on this
18 legislation to help get safe carbon monoxide detectors into more
19 homes.

20 Turning to H.R. 806, the Portable Fuel Container Safety Act
21 of 2019, this bill requires all consumer fuel container products
22 utilize a flame mitigation device, preventing dangerous flame
23 jetting from occurring.

24 Too many fuel containers with no mitigation devices have

1 caused severe burns and even death. These tragedies are
2 preventable.

3 Thank you, Margaret Lewis, for turning your family's tragedy
4 into a personal mission to prevent other families from having
5 to live through a similar nightmare. Your steadfast commitment
6 to your family on this issue got us to this point.

7 And while Mr. Griffith isn't on the subcommittee, I would
8 like to recognize his work on H.R. 2647, the Safer Occupancy
9 Furniture Flammability Act, or SOFFA. I share the goals of this
10 legislation but have concerns with the current draft that sets
11 a state technical bulletin as a federal standard.

12 We should have one set of standards for furniture
13 flammability, especially today when there's an increased risk
14 of fires across the country and in my district.

15 So thank you, everyone, for being a part of this markup today.

16 I understand that we will be voice voting the bills, and with
17 that, I will yield back.

18 Ms. Schakowsky. I thank the ranking member for yielding
19 back.

20 Some of what you said reminded me that while I thanked the
21 members and the staff, I didn't thank the advocates and,
22 particularly, we have heard from people whose children have
23 actually died who have come here so bravely to testify on behalf
24 of some of this legislation.

1 So thank you for that, and now I recognize the chairman of
2 the full committee, Mr. Pallone, for five minutes for an opening
3 statement.

4 The Chairman. Thank you, Madam Chair.

5 Today, we are considering six bills that will keep kids and
6 consumers safe from dangerous products as part of this committee's
7 commitment to put consumers first.

8 Madam Chair, I just wanted to say, you know, a lot of people
9 say that consumerism is dead and that, you know, the public or
10 the media don't pay attention to it and the Congress doesn't pay
11 attention to it.

12 But I want to commend you because from the very beginning
13 when you decided the chair, this subcommittee, you said that we
14 were going to put consumers first and that consumerism isn't dead
15 and that we need to do whatever we can to protect consumers, and
16 this is really part of that.

17 And the other thing too is, you know, I always hear people
18 say, well, you know, politicians don't care about kids because
19 kids don't vote, and the reality is that you care and this
20 committee cares on a bipartisan basis about kids and putting kids
21 and consumers first.

22 So I just wanted to say that by way of opening.
23 Congressional action is needed, given the failure of the Consumer
24 Product Safety Commission to act in recent years.

1 At recent hearings, we heard from parents, consumer
2 advocates, and even some commissioners that CPSC is too slow to
3 act, too timid, or too deferential to industry, and its inaction
4 has resulted in unnecessary injuries and, at times, cost Americans
5 their lives.

6 At our legislative hearing last month, we heard emotional
7 testimony from Crystal Ellis, whose son, Camden, was killed when
8 a dresser tipped over onto him.

9 She put a human face on the thousands of injured kids and
10 more than 200 killed by furniture tip-overs. Ms. Ellis told us
11 about the lack of action by industry to develop a voluntary
12 standard to reduce or eliminate furniture tip overs, and Chair
13 Schakowsky's STURDY Act would require CPSB to adopt a strong
14 mandatory standard within one year of enactment, and I commend
15 her for her leadership on this legislation.

16 We are also considering two bills today to reduce infant
17 deaths and promote safe sleep practices. Representative
18 Cardenas's Safe Sleep Act would ban dangerous inclined sleepers
19 that are responsible for at least 50 deaths. Some of these
20 sleepers have been recalled by others are still in stores and
21 online where soon-to-be parents or grandparents or well-meaning
22 friends may purchase them.

23 Crib bumpers are another hazardous children's product that
24 is still being sold, despite pediatricians urging parents not

2 For years, pediatricians and public health experts have
3 recommended against using crib bumpers because they can cause
4 suffocation, strangulation, entrapment, entanglement, or falls,
5 and they also provide no benefit to the baby.

6 Several cities and states have already banned crib bumpers
7 including Chicago, Ohio, and Maryland. But that is not enough.

8 It is time for Congress to act to make sure that babies are safe
9 from these products no matter where they live.

10 And we are also considering three bills that have long been
11 -- long had bipartisan support. Representatives Kuster and
12 Carter introduced the Nicholas and Zachary Burton Carbon Monoxide
13 Poisoning Prevention Act.

14 This bill would direct CPSC to establish a grant program
15 for states and local governments to install carbon monoxide alarms
16 in dwellings, child care facilities, schools, and senior centers,
17 and to assist with education and enforcement efforts to keep
18 Americans safe from this silent killer.

19 Representatives Thompson and Joyce introduced the Portable
20 Fuel Container Safety Act, which is also co-sponsored by numerous
21 Democrats and Republicans, and this legislation would require
22 CPSC to adopt a mandatory tool to prevent flame jetting in portable
23 fuel containers and improve child resistance controls on kerosene
24 and diesel fuel containers.

1 And finally, Representatives Matsui and Griffith introduced
2 the Safer Occupancy Furniture Flammability Act, which would adopt
3 California's furniture flammability standard for upholstered
4 furniture as the national flammability standard.

5 California's standard can be met without the use of toxic
6 flame retardant chemicals that endanger not only the families
7 that have these chemicals in their household furniture but also
8 firefighters who are exposed to them when battling fires.

9 As we heard from Captain Chris Parsons at our hearing last
10 month, these chemicals have caused severe health problems for
11 firefighters and I commend Representatives Matsui and Griffith
12 for their leadership on this issue.

13 So and all six of these bills will save American lives and,
14 particularly, kids, and that is why I am pleased to support them
15 and appreciate all your work, Chairman Schakowsky and the fact
16 that this is bipartisan.

17 I yield back.

2 Good morning. Welcome to the first Consumer Protection and
3 Commerce Subcommittee markup of the year, and today, as we have
4 heard, we will consider these six really important bills.

5 I know there's been a lot of discussion about them. I know
6 some of them are more ready for prime time than others. But I
7 know we are all working together in a good bipartisan spirit to
8 get them perfected by the full committee.

9 As I know you've made the commitment, Madam Chair, on the
10 FASTER Act we look forward to getting that in a good place as
11 well and we appreciate that the majority continue to work with
12 us on all of these, and I know there are still some issues.

13 But I want to thank Mrs. Rodgers for her leadership in this
14 area because this was once an award-winning fast track recall
15 program. But it has slowed to a crawl and we need to fix it.

16 So the fast track includes provisions of existing Consumer

18 the recall processes at the National Highway Traffic Safety

20 I think it's a real common sense bill. It puts consumers

2 possibility of furniture tip-overs. I believe that there should
3 be a safety standard to guide manufacturers as they seek to improve
4 furniture stability.

5 That is why I support making the current voluntary standard
6 mandatory so that the CPSC will have more enforcement tools to
7 go after bad actors.

8 CPSC is currently working through the rulemaking process
9 to allow them to do this. I do have concerns with how H.R. 2211
10 is currently drafted because the new standards it implements that
11 will significantly impact the engineering and testing of units
12 for furniture manufacturers that are making safe products.

5 And I -- my amendment in the nature of a substitute to H.R.
6 806 will make technical corrections based off of the assistance
7 provided by the Consumer Product Safety Commission.

8 This legislation originally introduced by the gentleman from
9 California, Mr. Thompson, would direct the CPSC to issue a
10 consumer product safety rule to require flame mitigation devices
11 in portable fuel containers in an effort to prevent terrible
12 accidents caused by jet flaming.

13 If it is determined that there are voluntary standards that
14 would prevent the propagation of flames into containers then the
15 CPSC would -- I should say could adopt these standards as their
16 rule.

17 We have heard the heart-wrenching stories here in this
18 subcommittee what happens to a loved one when one of the
19 jet-flaming incidence occurs.

20 With this legislation, it is my hope that we will educate
21 the public and prevent these injuries from happening in the future
22 and I encourage my colleagues to support this amendment in the
23 nature of a substitute, and yield back the balance of my time.

1 However, a lack of comprehensive action has, unfortunately,
2 allowed for a patchwork of regulations across the country on
3 flammability requirements, creating a difficult and burdensome
4 regulatory framework for furniture manufacturers.

5 Our bill would direct CPSC to take the California standard,
6 which is already almost a de facto federal standard, and apply
7 it nationally.

8 I am pleased that Mr. Griffith and I have put forward a common
9 sense solution that will ensure the integrity of our flammability
10 standards, provide certainty in the market, and reduce the threat
11 of exposure to health-harming chemicals.

12 This bill enjoys broad support from stakeholders, including
13 furniture companies, firefighters, and consumer protection
14 advocates.

15 I thank the subcommittee for including this important bill
16 in this markup, and I do look forward to continuing to work with
17 all interested parties as SOFFA moves through the process to
18 ensure it will pass Congress and benefit American consumers.

2 Mrs. Rodgers. Madam Chair, as I made clear earlier, I want
3 to move forward in a bipartisan manner, if possible. I agree
4 with the policy objectives of H.R. 2647, the SOFFA Act.

5 Providing national uniformity is critical to ensure
6 certainty for furniture manufacturers and retailers who support
7 jobs across the country.

8 However, I do have concerns with how H.R. 2647 was drafted.
9 The bill incorporates a state technical bulletin into federal
10 statute by reference.

11 As far as I know, this is unprecedented -- codifying a
12 standard into statute. That could have significant implications
13 for how it would be enforced.

14 We should also learn about more specific concerns that have
15 been raised within the CPSC about enforcement. I believe we can
16 move forward and provide certainty and set a national standard.

17 That needs to be our goal.

18 I am committed to working with you and the rest of our
19 colleagues on this bill, moving forward, and hope we can find
20 a bipartisan solution before the bill is marked up at the full
21 committee.
