Air Liquide is a non-refiner, meaning that the Company does not refine (“toll”) crude helium but relies on the six refining facilities that are owned by just four companies (“refiners”) to do so. Effectively, refiners control access to this federally-owned resource, and as BLM has testified, no new refineries can be supplied on the federal pipeline due to capacity constraints. Air Liquide as a non-refiner is seeking greater access to refined helium. Allowing greater access benefits end users by helping to create a more robust and competitive market.
