

COMMITTEE MARKUP ACTION SUMMARY REPORT

The Committee on Natural Resources met in open session on July 16, 2014, to consider the following bills:

H.R. 277 (Cicilline), To revise the boundaries of John H. Chafee Coastal Barrier Resources System Sachuest Point Unit RI-04P, Easton Beach Unit RI-05P, Almy Pond Unit RI-06, and Hazards Beach Unit RI-07 in Rhode Island.

The Subcommittee on Fisheries, Wildlife, Oceans and Insular Affairs was discharged from further consideration of H.R. 277 by unanimous consent.

- An Amendment offered by Mr. Fleming.001 was AGREED TO by unanimous consent.

Adopted and favorably reported to the House of Representatives, as amended, by unanimous consent.

H.R. 916 (Kind), To improve Federal land management, resource conservation, environmental protection, and use of Federal real property, by requiring the Secretary of the Interior to develop a multipurpose cadastre of Federal real property and identifying inaccurate, duplicate, and out-of-date Federal land inventories, and for other purposes (*Federal Land Asset Inventory Reform Act of 2013*).

The Subcommittees on Public Lands and Environmental Regulation, and Energy and Mineral Resources were discharged from further consideration of H.R. 916 by unanimous consent.

- An Amendment in the Nature of a Substitute offered by Mr. Lamborn.082 was AGREED TO by unanimous consent.

Adopted and favorably reported to the House of Representatives, as amended, by unanimous consent.

H.R. 1810 (Clawson), To revise the boundaries of John H. Chafee Coastal Barrier Resources System Gasparilla Island Unit in Florida.

The Subcommittee on Fisheries, Wildlife, Oceans and Insular Affairs was discharged from further consideration of H.R. 1810 by unanimous consent.

Adopted and favorably reported to the House of Representatives by unanimous consent.

H.R. 2158 (Fleming), To exempt from the Lacey Act Amendments of 1981 the expedited removal from the United States of certain snake species, and for other purposes (*Expedited Departure of Certain Snake Species Act*).

The Subcommittee on Fisheries, Wildlife, Oceans and Insular Affairs was discharged from further consideration of H.R. 2158 by unanimous consent.

- An Amendment offered by Mr. Fleming.001 was AGREED TO by unanimous consent.

Adopted and favorably reported to the House of Representatives, as amended, by unanimous consent.

H.R. 3572 (McIntyre), To revise the boundaries of certain John H. Chafee Coastal Barrier Resources System units in North Carolina.

The Subcommittee on Fisheries, Wildlife, Oceans and Insular Affairs was discharged from further consideration of H.R. 3572 by unanimous consent.

- An Amendment offered by Mr. Fleming.001 was AGREED TO by unanimous consent.

Adopted and favorably reported to the House of Representatives, as amended, by unanimous consent.

H.R. 3806 (Meadows), To authorize payment of funds in accordance with the agreement entered into by the Tennessee Valley Authority, the State of North Carolina, Swain County, North Carolina, and the United States Department of the Interior (*Great Smoky Mountains National Park Agreement Act of 2013*).

The Subcommittee on Public Lands and Environmental Regulation was discharged from further consideration of H.R. 3806 by unanimous consent.

- An Amendment in the Nature of a Substitute offered by Mr. Bishop of Utah.071 was AGREED TO by unanimous consent.

The long title was amended by unanimous consent.

Adopted and favorably reported to the House of Representatives, as amended, by unanimous consent.

H.R. 4751 (Kilmer), To make technical corrections to Public Law 110-229 to reflect the renaming of the Bainbridge Island Japanese American Exclusion Memorial, and for other purposes.

The Subcommittee on Public Lands and Environmental Regulation was discharged from further consideration of H.R. 4751 by unanimous consent.

Adopted and favorably reported to the House of Representatives by unanimous consent.
