**SUBJECT:** Committee on Natural Resources Markup – May 1, 2019

On **Wednesday, May 1, 2019, at 10:00 a.m. in Room 1324 Longworth House Office Building**, the Committee on Natural Resources is scheduled to hold a markup and consider the following bills:

- **H.R. 255** (Rep. Cook), To provide for an exchange of lands with San Bernardino County, California, to enhance management of lands within the San Bernardino National Forest, and for other purposes. (*Big Bear Land Exchange Act*)
- **H.R. 278** (Rep. Newhouse), To direct the Secretary of the Interior to convey certain facilities, easements, and rights-of-way to the Kennewick Irrigation District, and for other purposes.
- **H.R. 312** (Rep. Keating), To reaffirm the Mashpee Wampanoag Tribe reservation, and for other purposes. (*Mashpee Wampanoag Tribe Reservation Reaffirmation Act*)  
**Amendments to H.R. 312 must be drafted to the amendment in the nature of a substitute, attached to this notice.**
- **H.R. 315** (Rep. LaHood), To amend the Surface Mining Control and Reclamation Act of 1977 to authorize partnerships between States and nongovernmental entities for the purpose of reclaiming and restoring land and water resources adversely affected by coal mining activities before August 3, 1977, and for other purposes. (*Community Reclamation Partnerships Act*)
- **H.R. 375** (Rep. Cole), To amend the Act of June 18, 1934, to reaffirm the authority of the Secretary of the Interior to take land into trust for Indian Tribes, and for other purposes.  
**Amendments to H.R. 375 must be drafted to the amendment in the nature of a substitute, attached to this notice.**
- **H.R. 434** (Rep. Jackson Lee), To designate the Emancipation National Historic Trail, and for other purposes. (*Emancipation National Historic Trail Act*) **Amendments to H.R. 434 must be drafted to the amendment in the nature of a substitute, attached to this notice.**
- **H.R. 537** (Rep. Lamborn), To amend the Reclamation Project Act of 1939 to authorize pumped storage hydropower development utilizing multiple Bureau of Reclamation reservoirs. (*Bureau of Reclamation Pumped Storage Hydropower Development Act*)
- **H.R. 1014** (Rep. González-Colón), To amend the Outer Continental Shelf Lands Act to apply to territories of the United States, to establish offshore wind lease sale

- **H.R. 1146** (Rep. Huffman), To amend Public Law 115-97 (commonly known as the Tax Cuts and Jobs Act) to repeal the Arctic National Wildlife Refuge oil and gas program, and for other purposes. (*Arctic Cultural and Coastal Plain Protection Act*) **Amendments to H.R. 1146 must be drafted to the amendment in the nature of a substitute, attached to this notice.**
- **H.R. 1261** (Rep. DelBene), To establish a national program to identify and reduce losses from landslide hazards, to establish a national 3D Elevation Program, and for other purposes. (*National Landslide Preparedness Act*)
- **H.R. 1568** (Rep. Moulton), To assist in the conservation of the North Atlantic right whale by supporting and providing financial resources for North Atlantic right whale conservation programs and projects of persons with expertise required for the conservation of North Atlantic right whales, and for other purposes. (*SAVE Right Whales Act*) **Amendments to H.R. 1568 must be drafted to the amendment in the nature of a substitute, attached to this notice.**
- **H.R. 1809** (Rep. Sablan), To amend the Pittman-Robertson Wildlife Restoration Act and the Dingell-Johnson Sport Fish Restoration Act, to provide parity for United States territories and the District of Columbia, to make technical corrections to such Acts and related laws, and for other purposes.
- **H.R. 2156** (Rep. Cartwright), To amend the Surface Mining Control and Reclamation Act of 1977 to provide funds to States and Indian tribes for the purpose of promoting economic revitalization, diversification, and development in economically distressed communities through the reclamation and restoration of land and water resources adversely affected by coal mining carried out before August 3, 1977, and for other purposes. (*RECLAIM Act of 2019*) **Amendments to H.R. 2156 must be drafted to the amendment in the nature of a substitute, attached to this notice.**
