

**AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 1225
OFFERED BY MR. GRIJALVA OF ARIZONA**

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “Restore Our Parks
3 and Public Lands Act”.

**4 SEC. 2. NATIONAL PARK SERVICE AND PUBLIC LANDS LEG-
5 ACY RESTORATION FUND.**

6 (a) IN GENERAL.—There is established in the Treas-
7 ury of the United States a fund, to be known as the “Na-
8 tional Park Service and Public Lands Legacy Restoration
9 Fund” (referred to in this section as the “Fund”).

10 (b) DEPOSITS.—

11 (1) IN GENERAL.—Except as provided in para-
12 graph (2), for each of fiscal years 2020 through
13 2024, there shall be deposited in the Fund an
14 amount equal to 50 percent of all energy develop-
15 ment revenues due and payable to the United States
16 from oil, gas, coal, or alternative or renewable en-
17 ergy development on Federal land and water that

1 would otherwise be credited, covered, or deposited as
2 miscellaneous receipts under Federal law.

3 (2) MAXIMUM AMOUNT.—The amount deposited
4 in the Fund under paragraph (1) shall not exceed
5 \$1,300,000,000 for any fiscal year.

6 (3) EFFECT ON OTHER REVENUES.—Nothing
7 in this section affects the disposition under Federal
8 law, including the Gulf of Mexico Energy Security
9 Act of 2006 (43 U.S.C. 1331 note; Public Law 109–
10 432), the Mineral Leasing Act (30 U.S.C. 181 et
11 seq.), and chapter 2003 of title 54, United States
12 Code, of energy development revenues—

13 (A) to special funds, trust funds, or States;

14 or

15 (B) that have been otherwise appropriated
16 under Federal law.

17 (c) AVAILABILITY OF FUNDS.—Amounts deposited in
18 the Fund shall be available to the Secretary of the Interior
19 without further appropriation or fiscal year limitation.

20 (d) INVESTMENT OF AMOUNTS.—

21 (1) IN GENERAL.—The Secretary of the Inte-
22 rior may request the Secretary of the Treasury to
23 invest any portion of the Fund that is not, as deter-
24 mined by the Secretary of the Interior, required to
25 meet the current needs of the Fund.

1 (2) REQUIREMENT.—An investment requested
2 under paragraph (1) shall be made by the Secretary
3 of the Treasury in a public debt security—

4 (A) with a maturity suitable to the needs
5 of the Fund, as determined by the Secretary of
6 the Interior; and

7 (B) bearing interest at a rate determined
8 by the Secretary of the Treasury, taking into
9 consideration current market yields on out-
10 standing marketable obligations of the United
11 States of comparable maturity.

12 (3) CREDITS TO FUND.—The income on invest-
13 ments of the Fund under this subsection shall be
14 credited to, and form a part of, the Fund.

15 (e) USE OF FUNDS.—

16 (1) IN GENERAL.—Amounts in the Fund shall
17 be used as follows:

18 (A) Eighty percent of amounts in the
19 Fund shall be allocated for priority deferred
20 maintenance projects, including other infra-
21 structure deficiencies directly related to such
22 deferred maintenance projects, as determined
23 by the Secretary of the Interior and the Direc-
24 tor of the National Park Service, with the goal
25 of ensuring overall parity between amounts allo-

1 cated to transportation and non-transportation
2 projects.

3 (B) Ten percent of amounts in the Fund
4 shall be allocated for purposes of addressing the
5 national wildlife refuge system maintenance
6 backlog, as determined by the Secretary of the
7 Interior and the Director of the United States
8 Fish and Wildlife Service.

9 (C) Five percent of amounts in the Fund
10 shall be allocated for the purposes of addressing
11 the public access and recreation backlog on
12 public lands, as determined by the Secretary of
13 the Interior and the Director of the Bureau of
14 Land Management.

15 (D) Five percent of amounts in the Fund
16 shall be for the purposes of addressing the Bu-
17 reau of Indian Education school construction
18 and deferred maintenance backlogs, as deter-
19 mined by the Secretary of the Interior and the
20 Director of the Bureau of Indian Education.

21 (2) CONSIDERATION OF PROJECT LIFESPAN.—

22 The Secretary of the Interior shall take into consid-
23 eration the projected lifespan of any project under
24 this Act when prioritizing which such projects to
25 fund under paragraph (1).

1 (f) LIMIT ON USE OF FUNDS.—No more than 10 per-
2 cent of the amounts in the Fund may be used for adminis-
3 trative costs incurred in implementing this Act.

4 (g) PROHIBITED USE OF FUNDS.—No amounts in
5 the Fund shall be used—

6 (1) for land acquisition;

7 (2) to supplant discretionary funding made
8 available for the annually recurring facility oper-
9 ations, maintenance, and construction needs of the
10 entities for which amounts from the Fund are allo-
11 cated under subsection (e); or

12 (3) for performance awards for Federal employ-
13 ees who are employed in implementing this Act.

14 (h) SUBMISSION TO CONGRESS.—The Secretary of
15 the Interior shall submit to the Committees on Appropria-
16 tions and Natural Resources of the House of Representa-
17 tives and to the Committees on Appropriations and En-
18 ergy and Natural Resources of the Senate, with the annual
19 budget submission of the President, a list of projects for
20 which the amounts in the Fund are allocated under this
21 section, including a description of each such project.

22 (i) PUBLIC DONATIONS.—

23 (1) IN GENERAL.—The Secretary of the Inte-
24 rior, the Director of the National Park Service, the
25 Director of the United States Fish and Wildlife

1 Service, the Director of the Bureau of Land Man-
2 agement, and the Assistant Secretary of Indian Af-
3 fairs may accept public cash or in-kind donations
4 that advance efforts—

5 (A) to reduce the deferred maintenance
6 backlog of the National Park Service, the na-
7 tional wildlife refuge system maintenance back-
8 log of the United States Fish and Wildlife Serv-
9 ice, the public access and recreation backlog of
10 the Bureau of Land Management, and the
11 school construction backlog of the Bureau of
12 Indian Education, respectively; and

13 (B) to encourage relevant public-private
14 partnerships.

15 (2) CREDITS TO FUND.—Any cash donations
16 accepted under paragraph (1) shall be credited to,
17 and form a part of, the Fund.

18 (3) REPORTING.—Each donation received under
19 paragraph (1) that is used for, or directly related to,
20 the reduction of the deferred maintenance backlog of
21 the National Park Service, the national wildlife ref-
22 uge system maintenance backlog of the United
23 States Fish and Wildlife Service, the public access
24 and recreation backlog of the Bureau of Land Man-
25 agement, and the school construction backlog of the

1 Bureau of Indian Education, shall be included with
2 the annual budget submission of the President to
3 Congress.
