

Committee on Natural Resources – Markup Action Report

The Committee on Natural Resources met on Wednesday, October 13, 2021, to consider the following measures. [H.R. 160](#) (Rep. Soto), To reauthorize the Coral Reef Conservation Act of 2000 and to establish the United States Coral Reef Task Force, and for other purposes. *Restoring Resilient Reefs Act of 2021*.

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 160 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment in the nature of a substitute.
- Rep. Jenniffer González-Colón (R-PR) offered an amendment designated González-Colón #1 to the amendment in the nature of a substitute. The amendment was agreed to by voice vote.
- The Grijalva amendment in the nature of a substitute, as amended, was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by voice vote.

[H.R. 442](#) (Rep. Young), To provide for the conveyance of certain property to the Southeast Alaska Regional Health Consortium located in Sitka, Alaska, and for other purposes. *Southeast Alaska Regional Health Consortium Land Transfer Act*.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 442 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 570](#) (Rep. McEachin), To require operators of offshore oil and gas facilities to report failures of critical systems to the Secretary of the Interior, and for other purposes. *Offshore Accountability Act of 2021*.

Subcommittee on Energy and Mineral Resources and the Subcommittee on National Parks, Forests, and Public Lands were discharged from further consideration of H.R. 570 by unanimous consent.

- Rep. Matt Rosendale (R-MT) offered an amendment designated Rosendale #1. The amendment was not agreed to by a roll call vote of 19 yeas and 24 nays.
- Rep. Garret Graves (R-LA) offered an amendment designated Graves #1. The amendment was not agreed to by a roll call vote of 19 yeas and 25 nays.
- The bill was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 25 yeas and 19 nays.

[H.R. 897](#) (Rep. Ruiz), To take certain lands in California into trust for the benefit of the Agua Caliente Band of Cahuilla Indians, and for other purposes. *Agua Caliente Land Exchange Fee to Trust Confirmation Act*.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 897 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 1286](#) (Rep. Clyburn), To establish in the States of North Carolina and South Carolina the Southern Campaign of the Revolution National Heritage Corridor, and for other purposes. *Southern Campaign of the Revolution National Heritage Corridor Act of 2021.*

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 1286 by unanimous consent.

- Ranking Member Bruce Westerman (R-AR) offered an amendment designated Westerman #1 to the amendment in the nature of a substitute. The amendment was agreed to by unanimous consent.

- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 1975](#) (Rep. Issa), To take certain land located in San Diego County, California, into trust for the benefit of the Pala Band of Mission Indians, and for other purposes. *Pala Band of Mission Indians Land Transfer Act of 2021.*

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 1975 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2024](#) (Rep. Hoyer), To establish the Southern Maryland National Heritage Area, and for other purposes. *Southern Maryland National Heritage Area Act.*

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 2024 by unanimous consent.

- Chair Grijalva offered an amendment in the nature of a substitute.
- Ranking Member Westerman offered an amendment designated Westerman #1 to the amendment in the nature of a substitute. The amendment was agreed to by unanimous consent.
- The Grijalva amendment in the nature of a substitute, as amended, was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2074](#) (Rep. Young), To assist Tribal governments in the management of buffalo and buffalo habitat and for the reestablishment of buffalo on Indian lands. *Indian Buffalo Management Act.*

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 2074 by unanimous consent.

- Rep. Don Young (R-AK) offered an amendment designated Young #1. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2088](#) (Rep. Fleischmann), To take certain Federal lands in Tennessee into trust for the benefit of the Eastern Band of Cherokee Indians, and for other purposes. *Eastern Band of Cherokee Historic Lands Reacquisition Act*.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 2088 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2107](#) (Rep. Rutherford), To establish the Nation's Oldest Port National Heritage Area in the State of Florida, and for other purposes. *Nation's Oldest Port National Heritage Area Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 2107 by unanimous consent.

- Chair Grijalva offered an amendment in the nature of a substitute.
- Ranking Member Westerman offered an amendment designated Westerman #1 to the amendment in the nature of a substitute. The amendment was agreed to by unanimous consent.
- The Grijalva amendment in the nature of a substitute, as amended, was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2643](#) (Rep. Brownley), To require the Bureau of Safety and Environmental Enforcement to further develop, finalize, and implement updated regulations for offshore oil and gas pipelines to address long-standing limitations regarding its ability to ensure active pipeline integrity and address safety and environmental risks associated with decommissioning, and for other purposes. *Offshore Pipeline Safety Act*.

Subcommittee on Energy and Mineral Resources was discharged from further consideration of H.R. 2643 by unanimous consent.

- Rep. Rosendale offered an amendment designated Rosendale #1. The amendment was not agreed to by a roll call vote of 16 yeas and 23 nays.
- Rep. Rosendale offered an amendment designated Rosendale #2. The amendment was withdrawn.
- Rep. Rosendale offered an amendment designated Rosendale #3. The amendment was not agreed to by a roll call vote of 18 yeas and 25 nays.

- By unanimous consent, Rep. Jerry Carl (R-AL) offered an amendment on behalf of Rep. Graves designated Graves #2. The amendment was agreed to by voice vote.
- Rep. Graves offered an amendment designated Graves #3. The amendment was not agreed to by a roll call vote of 17 yeas and 24 nays.
- Rep. Graves offered an amendment designated Graves #4. The amendment was not agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 25 yeas and 18 nays.

[H.R. 2930](#) (Rep. Leger Fernández), To enhance protections of Native American tangible cultural heritage, and for other purposes. *Safeguard Tribal Objects of Patrimony Act of 2021*.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 2930 by unanimous consent.

- Rep. Teresa Leger Fernández (D-NM) offered an amendment designated Leger Fernández #1. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 3075](#) (Rep. Huffman), To address seafood slavery and combat illegal, unreported, or unregulated fishing, and for other purposes. *Illegal Fishing and Forced Labor Prevention Act*.

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 3075 by unanimous consent.

- Rep. Jared Huffman (D-CA) offered a manager's amendment with Rep. Graves designated Huffman-Graves #036. The amendment was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by voice vote.

[H.R. 3222](#) (Rep. Sewell), To establish the Alabama Black Belt National Heritage Area, and for other purposes. *Alabama Black Belt National Heritage Area Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 3222 by unanimous consent.

- Chair Grijalva offered an amendment in the nature of a substitute.
- Ranking Member Westerman offered an amendment designated Westerman #1 to the amendment in the nature of a substitute. The amendment was agreed to by unanimous consent.
- The Grijalva amendment in the nature of a substitute, as amended, was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 3670](#) (Rep. Neguse), To improve access for outdoor recreation through the use of special recreation permits on Federal recreational lands and waters, and for other purposes. *Simplifying Outdoor Access for Recreation Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 3670 by unanimous consent.

- Rep. Blake Moore (R-UT) offered an amendment designated Moore #1. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 4881](#) (Rep. Grijalva), To direct the Secretary of the Interior to take into trust for the Pascua Yaqui Tribe of Arizona certain land in Pima County, Arizona, and for other purposes. *Old Pascua Community Land Acquisition Act*.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 4881 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 5221](#) (Rep. Grijalva), To amend the Indian Health Care Improvement Act to establish an urban Indian organization confer policy for the Department of Health and Human Services. *Urban Indian Health Confer Act*.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 5221 by unanimous consent.
