

The Planned Parenthood counselors lied and told me that the fetus was just a blob of tissue, not a baby. They didn't talk about the stage of development, a heartbeat, just that it was tissue.

9. How has abortion affected you?

For many years I lived in denial and tried to forget it ever happened, but it changes you forever. I suffered from insomnia, depression, guilt, anxiety for many years, not realizing what the root cause was, until I became a Christian in 1985. I knew that what I had done was wrong and even though I knew the Lord had forgiven me, it was many more years before I was able to forgive myself. I married a man who didn't want children and when we later divorced, I was devastated--the feelings of worthlessness were overwhelming, at least in part, because I knew I would never bear a child and the only children I would ever have, I aborted--murdered. I regret my decision to abort my babies, there is so much sadness that never goes away. Only after I received total healing from the Lord, have I been able to enjoy friends babies and truly connect emotionally.

10. How has your abortion affected others in your life?

When my step-daughter and daughter-in-law were pregnant, I was unable to share the normal things a mother shares with them--I felt I'd let them down and it was heartbreaking. My friends probably don't know why I seemed distant around their babies, but they surely felt it. Some of my family relationships are strained. I have hope that those relationships will be healed by the Lord, but I wonder what my life would have been like if things had been different. One of my sisters tried to talk me out of the abortion--she was the only one who fought hard for life--I know it hurt her that I didn't listen and she would have been a good Aunt, as she is to our other nieces and nephews. Someone is missing at the table--that's the sad realization that we come to and it will never be healed until we get to heaven and are reunited.

11. Based upon your experience, what would you tell a woman considering abortion?

I regret my abortion--there is so much sadness that never goes away. The reality of your loss increases with time, not decreases. You'll wonder what you're child would look like, be like. If you are ever fortunate enough later in life to have grandchildren, you'll wonder what your other grandchildren would be like. One life touches another, every life matters. There is always a way to do what we think we can't do and you are not alone. There is loving, compassionate help for you and your baby. You CAN do it, you really can have a baby and it will be alright. With God, all things are possible.

12. Based on your own experience, what would you tell a court that believes abortion should be legal?

Legal abortion hurts women, it hurt me--emotionally, physically, and spiritually. It torments, and sometimes maimes and kills women. To deny a child life because it's inconvenient for the mother, or because of the circumstances of conception, or disability of the child, is wrong because it lacks true compassion for either the mother or the baby. My abortion may have been legal, but it caused me great harm and killed my child who had a right to live. There are two lives to be considered, not just one. That is the heart of the matter--why do we think we have the right to murder a human life? Abortion should not only be illegal, it should be unthinkable.

I did not know that the abortion would pull the baby apart in pieces. I did not know that the heart was beating. I did not know that once the laminaria was placed in my cervix that I could still stop the abortion. I did not know it would be physically painful to have an abortion. I did not know that I would feel loss and grief. Nobody bothered to tell me these things.

In all fairness at this late date I can't say exactly what was taught to me prior to the procedure. I can't say whether or not I was informed, or I was just so distraught at the time that I wasn't able to listen and fully understand what they were telling me. However, I was very surprised by what I found out after the abortion. I had no idea that it would hurt, and that there was a possibility that I would have pain after the procedure. I definitely didn't know that I would be severely depressed and guilt ridden. Nobody approached the subject of how I would feel about it. Nobody told me that I would have problems bonding with my other children, and that I would have problems trusting my mothering abilities. Nobody told me that I would have problems with relationships in general after that, or that I would seek to replace the "lost" child.

Once I married I tried to repair the relationship, but it was too late. I've caused others in my life the same pain of abortion by being afraid to tell my "secret". Subsequently my step-daughter experienced a horrible abortion where she screamed through the whole procedure (she was un-medicated) and cried for her Daddy! It destroyed her relationship with her Dad and her own self esteem. She also sought to replace the "lost" child, and became pregnant and married at a very early age after this. I felt like I was not worthy of love, and therefore it took my husband years and years of patiently loving and caring for me to convince me that he really did love me and that I was loveable. It caused a lot of stress in our marriage.

11. Based upon your experience, what would you tell a woman considering abortion?

I have told them the truth about what abortion really does physically to them and the child. I make sure they know that the child's heart is most likely already beating and that the nervous system is developing. I've told them how abortion affects so many aspects of their lives especially their relationships with others, and most importantly their relationships subsequent children. I've told them that adoption is a great alternative and that I wish I had opted for that instead of abortion. Although I didn't think I could do it at the time, I've since been witness to several adoptions and see it as such a beautiful gift to all concerned. I also tell them of the resources offered at Crisis Pregnancy Centers to help them along while they are deciding what to do. I also tell them that they are there to help them learn to parent through parenting classes, and help provide them with needed supplies and resources for their new child if they should decide to parent.

12. Based on your own experience, what would you tell a court that believes abortion should be legal?

First of all I would tell them all of what I have previously stated. Then I would tell them that instead of legalized abortion providing a safe way for women to end their unwanted pregnancies, they have in fact contributed to far more deaths, inadvertent sterilizations, and abortion caused mutilations that ever would have happened if abortion would have been kept illegal, simply because of the increased numbers due to the greater social acceptance. Abortion has most likely increased the numbers of women who are heavy drug and alcohol users, promiscuous, depressed and even mentally ill. Post Abortion Syndrome, very closely related to PTSD, is a newer more prevalent mental disorder caused by abortion. Abortion has also devalued human life to the extent that people don't see their children as valuable as they did in the past. 

I think about the baby every day. I wish I would have made a different choice. The guilt and the horror of what I did is very hard to deal with. I am fortunate that I now have a great relationship with God and I know He forgives me, since I have begged for that. I am waiting for me to forgive me.

10. How has your abortion affected others in your life?

It is hard to talk about and the people I have told have been understanding. But, again, forgiving myself for the choice I made so long ago is quite another thing. Guilt and deep remorse follow me around always.

DONT DO IT!!!! You will regret it at some point in your life and the regret will NEVER go away.

By the way the day of the procedure, I BEGGED the nurse and the doctor NOT to perform the process, to remove the "seaweed" tampon thing that was dilating my cervix and let me go. They refused, I was yelled at by the doctor and told I was "wasting" everyone in the clinic's "time" and that I would "lose the baby anyway" if he did that...so I should just "be quiet" and submit to the procedure. After it was over I was kicked out of the room because a nurse said I had to leave because they had other girls and they "needed the room". I passed out on the elevator and my boyfriend had to physically carry me to the car. I lost my job for an abortion I didn't even want or expect. I lost my life for 30 years afterwards.

Everyone said I should just get on with my life and let it go. But I

couldn't. They were my children, too. Those women understood. They had been there. Our stories were different, but our pain was the same. Although I have answered yes here, I still believe there is need for explanation. When a young girl who is scared to death about everything that's going on around her is explained medical terms, it doesn't sink in right away. Plus, I was told that not many women feel bad after an abortion--WRONG! I don't personally know any women who've had one, but from reading these declarations, I see that the majority of women suffer greatly for years.

5. Were you adequately informed of the consequences of abortion?

I did not know that ten years after the abortion I would still feel guilty. That I'd have problems in my marriage to a man whom I didn't even know at the time of the abortion. That I'd feel like wrapping barbed wire around my neck or jumping into the creek by my house in sub-zero temperatures. Or that when I look into my baby's eyes and ache for those eyes I never saw.

9. How has abortion affected you?

I've had marital problems, suicidal thoughts, depression, guilty feelings. Today I'm crying about it as though it were the day it happened. I don't recall much from my childhood or even recent events as a result of blocking my memory to protect myself from that horrible memory that I made that day. I still see my little baby on the green and black ultrasound image, sucking her thumb. Part of me died with her that day.

10. How has your abortion affected others in your life?

There are family members who don't know, maybe never will. My depression has made me somewhat psychotic, putting a strain on my loving husband who is having a hard time trying to understand where I'm coming from. I still haven't forgiven myself for going through with it, or my mother for suggesting it.

11. Based upon your experience, what would you tell a woman considering abortion?

I would tell her absolutely do NOT do it. Put the baby up for adoption or raise the baby yourself. I would show her the 3-D ultrasound images of fetal development that I got the second time I became pregnant. I would tell her how I saw my daughter's heartbeat on ultrasound when I was only 5 weeks pregnant. I would tell her that even though it may be hard to go through with the pregnancy now, an abortion will haunt her for the rest of her life, but she will never regret giving life. Being pregnant made me feel like such a woman and giving life made me feel like God's creation more than I have ever felt like I was made for a reason. If I could go back to that abortion clinic on that day, instead of thinking "no, stop! Don't do this, this isn't what I want!" I would SAY it-no, I would SCREAM it!

12. Based on your own experience, what would you tell a court that believes abortion should be legal?

Something that makes a person torture themselves this way should not be legal. I have been depressed, psychotic, suicidal, and have cried more over this one isolated incident than I have ever cried over anything in my life. I would hope that if I were captured by an enemy and they were putting me through this torture that my government would step in, rescue me and put my captors on trial. But, in this case, my captors have been given free reign to continue doing this type of torture to millions of other women legally. It's an atrocity what our government is letting the enemy get away with these days.
