## A BILL

To amend the Elder Abuse Prevention and Prosecution Act to authorize the Elder Justice Initiative, to require that online resources of such initiative are made available in Spanish, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Elder Abuse Protection  
5 Act of 2020”.

1 **SEC. 2. ELDER JUSTICE INITIATIVE.**

2 Section 101(b) of the Elder Abuse Prevention and  
3 Prosecution Act (34 U.S.C. 21711(b)) is amended to read  
4 as follows:

5 “(b) ELDER JUSTICE INITIATIVE.—

6 “(1) PERMANENT INITIATIVE.—The Attorney  
7 General shall establish within the Criminal Division  
8 an Elder Justice Initiative to coordinate criminal en-  
9 forcement and public engagement efforts to combat  
10 elder abuse, neglect, and financial fraud and scams  
11 that target elders, and to support and coordinate the  
12 efforts of the Elder Justice Coordinators designated  
13 under subsection (a).

14 “(2) DEPARTMENT OF JUSTICE ELDER JUSTICE  
15 COORDINATOR.—The Attorney General shall des-  
16 ignate an Elder Justice Coordinator within the De-  
17 partment of Justice who, in addition to any other re-  
18 sponsibilities, shall be responsible for—

19 “(A) coordinating and supporting the law  
20 enforcement efforts and policy activities as the  
21 head of the Elder Justice Initiative for the De-  
22 partment of Justice on elder justice issues;

23 “(B) evaluating training models to deter-  
24 mine best practices and creating or compiling  
25 and making publicly available replication guides  
26 and training materials for law enforcement offi-

1           cers, prosecutors, judges, emergency respond-  
2           ers, individuals working in victim services, adult  
3           protective services, social services, and public  
4           safety, medical personnel, mental health per-  
5           sonnel, financial services personnel, and any  
6           other individuals whose work may bring them in  
7           contact with elder abuse regarding how to—

8                   “(i) conduct investigations in elder  
9                   abuse cases;

10                   “(ii) address evidentiary issues and  
11                   other legal issues; and

12                   “(iii) appropriately assess, respond to,  
13                   and interact with victims and witnesses in  
14                   elder abuse cases, including in administra-  
15                   tive, civil, and criminal judicial pro-  
16                   ceedings; and

17                   “(C) carrying out such other duties as the  
18           Attorney General determines necessary in con-  
19           nection with enhancing the understanding, pre-  
20           vention, and detection of, and response to, elder  
21           abuse.

22                   “(3) ONLINE PUBLIC RESOURCES.—The Elder  
23           Justice Initiative shall maintain and publish on the  
24           internet, information aimed at protecting elders

1 from fraudulent schemes and contain resources  
2 aimed at preventing elder abuse.

3 “(4) SPANISH LANGUAGE RESOURCES.—The  
4 Attorney General shall ensure that Elder Justice  
5 Initiative online resources are available in Spanish  
6 and link linguistically appropriate resources to in-  
7 form Spanish-speaking elders of Federal and State  
8 resources to combat fraud and abuse that targets  
9 the elderly, to include—

10 “(A) Spanish-language resources and links  
11 that help report instances of elder fraud and  
12 abuse to State and local law enforcement; and

13 “(B) resources that help prevent financial  
14 exploitation of elders.”.
