Mr. McCLINTOCK (for himself, Mr. WILSON of South Carolina, Ms. TENNEY, Mrs. WAGNER, Mr. EDWARDS, Mrs. HOUCHIN, Mr. HUNT, and Mr. CRANK) introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To amend the Immigration and Nationality Act with respect to aliens who carried out, participated in, planned, financed, supported, or otherwise facilitated the attacks against Israel.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Immigration Bene-
5 fits for Hamas Terrorists Act”.

1 **SEC. 2. ALIENS WHO CARRIED OUT, PARTICIPATED IN,**
2 **PLANNED, FINANCED, SUPPORTED, OR OTH-**
3 **ERWISE FACILITATED ATTACKS AGAINST**
4 **ISRAEL.**

5 (a) **PARTICIPANTS IN HAMAS TERRORISM AGAINST**
6 **ISRAEL.**—Section 212(a)(3) of the Immigration and Na-
7 tionality Act (8 U.S.C. 1182(a)(3)) is amended—

8 (1) in subparagraph (B)(i), in the matter fol-
9 lowing subclause (IX)—

10 (A) by inserting “Palestinian Islamic
11 Jihad, or Hamas” after “Palestine Liberation
12 Organization”; and

13 (B) by inserting “member,” after “rep-
14 resentative,”; and

15 (2) by adding at the end the following:

16 “(H) **PARTICIPANTS IN HAMAS TERRORISM**
17 **AGAINST ISRAEL.**—Any alien who carried out,
18 participated in, planned, financed, afforded ma-
19 terial support to, or otherwise facilitated any of
20 the attacks against Israel initiated by Hamas
21 beginning on October 7, 2023, is inadmissible.”.

22 (b) **INELIGIBILITY FOR RELIEF.**—Section 241(b)(3)
23 of the Immigration and Nationality Act (8 U.S.C.
24 1231(b)(3)) is amended by adding at the end the fol-
25 lowing:

1 “(D) INELIGIBILITY FOR RELIEF.—Any
2 alien who carried out, participated in, planned,
3 financed, afforded material support to, or other-
4 wise facilitated any of the attacks against Israel
5 initiated by Hamas beginning on October 7,
6 2023, shall be ineligible for any relief under the
7 immigration laws, including under this section,
8 section 208, and section 2242 of the Omnibus
9 Consolidated and Emergency Supplemental Ap-
10 propriations Act, 1999 (and any regulations
11 issued pursuant to such section).”.

12 (c) CONFORMING AMENDMENT.—Section
13 237(a)(4)(B) of the Immigration and Nationality Act (8
14 U.S.C. 1227(a)(4)(B)) is amended by striking “subpara-
15 graph (B) or (F)” and inserting “subparagraph (B), (F),
16 or (H)”.

17 (d) REPORT REQUIRED ON PARTICIPANTS IN HAMAS
18 TERRORISM AGAINST ISRAEL.—Beginning not later than
19 one year after the date of the enactment of this Act, and
20 each year thereafter, the Secretary of Homeland Security
21 shall submit a report to Congress, including the number
22 of aliens who were—

23 (1) found to be inadmissible under section
24 212(a)(3)(H) of the Immigration and Nationality
25 Act (8 U.S.C. 1182(a)(3)(H)); and

1 (2) described in section 212(a)(3)(H) of the Im-
2 migration and Nationality Act (8 U.S.C.
3 1182(a)(3)(H)) and found to be removable pursuant
4 to section 237(a)(4)(B) of the Immigration and Na-
5 tionality Act (8 U.S.C. 1227(a)(4)(B)).
