## More than 100 American Victims of Muslim Ban

On September 24th, 2019, a joint hearing on the impact of the Muslim Ban is scheduled with the House Foreign Affairs Subcommittee on Oversight and Investigations and the House Judiciary Subcommittee on Immigration and Citizenship.

Below are **more than 100 stories of American families impacted by** from across the nation.

### Alaska

**Anchorage, AK** - Shokrollah Hassani is a permanent resident who is separated from his wife, who has been stuck in the visa process for three years. (Source: [in-it](#), contact: [shiva@in-it.com](mailto:shiva@in-it.com))

### Arizona

**Chandler, AZ** - Erfan Mohammadi is a chemical engineering student whose parents are unable to visit or attend his graduation in the U.S. He was also temporarily separated from his fiancé who experienced delays in obtaining her student visa. (Source: [Daily Illini](#))

**Tempe, AZ** - Maral Charkhtab Tabrizi is a lawful permanent resident of the U.S. and an Iranian-American who is being denied the help and support of her Iranian parents as she raises a newborn and works a full-time job, all while suffering from a chronic and painful medical condition. **Tempe, AZ** - Asmaa Khadem Al Arbaiin, an English student, was denied a visa to enter the U.S. from Istanbul, keeping her apart from her husband, Ramez Alghazzouli. (Source: [Huffington Post](#))

**Tucson, AZ** - Shaghayegh Ansari was born in Iran and lives in Arizona. His mother and his father, diagnosed with brain cancer, were prevented from coming to the U.S. to see their son. (Source: [ACLU](#))

## Arkansas

**Little Rock, AR** - Mohammed Al-Awadhi came to the U.S. in 2007 and is an internal medicine physician at a hospital in Little Rock, AR. His wife Rasha had her visa interview in Djibouti in Dec. 2017. Rasha was living in Sanaa at the time, and the nearby airport was no longer functioning. Despite having rheumatic heart disease and unreliable access to medicine, Rasha traveled for one month across risky desert borders and airline layovers in three different countries in order to get to Djibouti for the interview. Consular officers told her she would be granted a visa, but, when she returned to pick it up a few weeks later, they informed her it must be denied because the Muslim Ban had gone into effect. They were then told a waiver had been granted, but then received no response from the embassy. (Source: [Washington Post](#))

## California

**Citrus Heights, CA** - Mike Izadjou's fiance Shala has been living abroad, unable to join him while she waits for her visa to be processed. (Source: [Fox 40](#))

**San Jose, CA** - Bamshad Azizi is a lawful permanent resident of the U.S. whose Iranian parents are recovering from cancer and surgery. Because of the Muslim Ban, they may live the rest of their lives without being able to visit their family in the United States. Bamshad is a plaintiff in *Emami v. Trump*. **Antioch, CA** - Mania Aghdasi's father lived abroad and was unable to visit her in the U.S. following the death of his son because his case was in administrative processing. Aghdasi was eventually able to visit him in Iran before he passed away. ([Mother Jones](#))

**Azusa, CA** - Laura Kakish is a U.S.-born citizen. Her husband previously lived in the U.S. for 16 years on a student visa and left after completing his education. However, now he can't get a visa to come live with his wife. (Source: [Washington Post](#))

**Bakersfield, CA** - The mother of Angham Aldawood, who was hit by a car and has deteriorating health, has not been able to come to the U.S. to be with her daughter and her family. (Source: [The Californian](#))

**Berkeley, CA** - Marzieh Mirmobini is a permanent resident studying in the U.S. who is separated from his husband, who can't obtain a visa. (Source: [in-it](#), contact: [shiva@in-it.com](mailto:shiva@in-it.com))

**Huntington Beach, CA** - Farzan Nematollah's wife lives in Iran and is dealing with worsening health conditions but the waiver process has kept them from living together. (Source: [KTLA](#))

**Irvine, CA** - Mehrshad Alexander Mehrdad is a U.S. citizen living in California. His fiancé can't get a visa to come live with him and the stress of her immigration circumstances is causing her mental and physical health problems. (Source: [Washington Post](#))

**Irvine, CA** - Amin Sirati and Shamim Darchini met in Iran in 2013 and married two years later. Amin has been unable to join his wife who resides in California because his waiver has been pending. (Source: [CNN](#))

**La Jolla, CA** - Mohammad Reza Mirzaeian, a 75-year-old man living in the United Arab Emirates with failing health has not been able to join his wife and son in California. (Source: [Voice of San Diego](#))

**Los Angeles, CA** - Ehsan Momeni lives in the U.S. on a student visa who is separated from his mother, who can't come to the U.S. to visit her son because of the Muslim Ban. (Source: [in-it](#), contact: [shiva@in-it.com](mailto:shiva@in-it.com))

**Los Angeles, CA** - Alia Ali, an artist and U.S. citizen, was unable to travel to Yemen to visit her dying grandmother. (Source: [artnet](#))

**Oakland, CA** - Shaima Swileh's husband, Ali, is an American citizen. Their two-year-old son was dying of a degenerative brain condition, and Shaima's waiver application was pending. After intense social and traditional news media coverage, Shaima's waiver was granted and she was able to enter the U.S. to be with her son when he died. (Source: [New York Times](#))

**San Diego, CA** - The mother of Dhana Nur, a Somali immigrant, was denied a visa and has been separated from her son and his family. (Source: [San Diego Union-Tribune](#))

**San Diego, CA** - The elderly, ailing father of Sawyer Mirage, a U.S. citizen living in California, has not been able to obtain a visa to leave Iran and live with his family in the U.S. (Source: [Voice of San Diego](#))

**San Diego, CA** - Leili Mortazavi is an undergraduate student at the University of British Columbia and an Iranian citizen. She was chosen to present at the Society for Neuroscience (SfN) meeting in San Diego but was unable to obtain a visa. (Source: [Ars Technica](#))

**San Francisco, CA** - Maryam Mozafari lives in California and wanted her parents, both of whom live abroad, to visit and provide support while she was pregnant. Even though her parents had visited the U.S. as recently as 2014 and left the country well in advance of the expiration of their visas, her father was forced to spend months submitting documents and navigating red tape only to have his visa denied. Her mother was only able to come visit for a short time because her husband, Maryam's father, suffers from a heart condition which requires that he be accompanied at all times. **San Francisco, CA** - Anas Tresh is a medical student at the University of California whose grandmother is unable to visit him and other family members as she lives in Libya. (Source: [New York Daily News](#))

**Stanford, CA** - Murad Subay and his wife Hadil, who is studying at Stanford University, are unable to visit one another for fear that she would not be allowed back into the U.S. after travelling to Yemen. (Source: [Al Jazeera](#))

**Redlands, CA** - Hani Fouladgar's sister is a medical school graduate living in Iran who is unable to come to the U.S. to be with her family. (Source: National Iranian American Council, contact: [donna@niacaction.org](mailto:donna@niacaction.org))

**California** - Nageeb Alomari is a U.S. citizen whose Yemeni daughter who suffers from severe cerebral palsy. She can't speak or move on her own. She also needs to take medicine four to five times a day to keep her muscles relaxed and to keep her from having spasms. But she was living in Yemen, where there was a shortage of medicine. Nageeb went to Yemen to wait with his family for their visa application to be adjudicated. After a five-minute interview in Djibouti, their visas were denied. One day before Supreme Court arguments about the ban, Shaema's waiver was approved. In May 2018, she arrived in the United States. (Source: [Washington Post](#))

**California** - The two-year-old son of Abdullah Hassan and Shaima Swileh was fighting a degenerative brain disease. Swileh, a Yemeni woman living in Egypt, struggled to obtain a waiver and was only granted one and allowed into the U.S. to embrace her son in his dying days after a great deal of publicity and public pressure. **California** - An immigrant from Yemen living in the U.S. and working as a dentistry professor was diagnosed with leukemia. His relatives from Yemen needed to come to the U.S. to be matched as bone marrow donors but had trouble obtaining visas. (Source: [San Gabriel Valley Tribune](#))

**California** - Mohammadhossein Moshkelgosha is a doctor living in Iran who passed the United States Medical Licensing Examination. He has been unable to come to the U.S. to live with his wife, a legal permanent resident of the U.S. since 2013. (Source: [Washington Post](#))

Both applied for visitor visas, but were denied at their visa interviews. Embassy officials told them that Arefeh's wedding was not enough to get around the Muslim Ban and they had to give up trying to come in time for Arefeh's wedding. ## Louisiana

**Crowley, LA** - Mahmood Salem moved his family from Yemen to Djibouti in 2016. Their visas were approved in Nov. 2017, but the ban went into effect before they could be issued, and they were subsequently denied. Mahmood died by suicide after his wife and two oldest children were denied visas. The government issued waivers for them five days after his suicide. They arrived in the U.S. too late to attend his funeral. (Source: [NBC News](#))

**Baltimore, MD** - Abdollah Dehzangi is a permanent resident and a professor at Morgan State University who is separated from his wife, who lives abroad. His wife has a PhD and has secured a job in the U.S. as a researcher but can't come here. (Source: [in-it](#), contact: [shiva@in-it.com](mailto:shiva@in-it.com))

**Bethesda, MD** - Leila Sasantour and her husband live in the U.S. but her parents' green card has not yet been processed to allow them to visit. This has slowed Leila's schooling and made it more difficult for her to care for her baby. (Source: [The Sentinel](#))

**Rockville, MD** - Mitra Farnoodian-Tedrick lives in Rockville, Maryland with her husband, a U.S. citizen. Her mother and father, who both live in Iran, are unable to obtain visas to see their daughter. This forced Mitra and her husband to cancel the wedding celebration and endure thousands of dollars in expenses due to non-refundable deposits, filing fees, travel costs and other visa-related costs as well as significant emotional distress from having to celebrate their wedding without their closest relatives. German doctors encouraged her to get more sophisticated medical treatment in the U.S. following 13 operations to repair trauma from third-degree burns to her face, arms, and chest. In Dec. 2018, U.S. denied her visa, claiming that there was not enough evidence to prove Marwa would return to Germany after her medical treatment. (Source: [The Guardian](#))

When war broke out, he began the process of bringing his wife and their four children to the United States. His wife's visa application stalled, and the family fled to Egypt in 2017. Mohamed visited in October 2018, and got in a car crash. He and three of his daughters then returned to the United States. After seven surgeries, Mohamed couldn't work, and had to send two of his daughters to live with his brother in North Carolina. One daughter remains in Egypt with his wife. **Brooklyn, NY** - Mohammed is a U.S. citizen. His wife and five-year-old daughter Aziza had visa interviews in Djibouti in October 2017. A few days later, they granted his daughter's visa. But Aziza's processing took three months, and ended with a visa rejection and waiver denial. Mohammed and his daughter have returned to the U.S., and Aziza has gone to Jordan to stay with Mohammed's brother. They don't know when they'll have a future together as a family again.
