Trial Practice/ Civil Procedure

Before becoming a judge, I taught courses sponsored by the Massachusetts Continuing Legal Education - New England Law Institute (MCLE-NELI) and the National Institute of Trial Advocacy nearly every year since August of 1978. In addition, I have served as a teacher in Harvard Trial Advocacy Workshops for the training of Harvard law students.
