# Federal Criminal Defense Clinic (FCDC)

Founded, designed, and direct the second trial-level federal criminal defense clinic in the nation. Supervise students in their representation of indigent people charged with crimes in the U.S. District Courts for the Northern and Southern Districts of Iowa and the U.S. Courts of Appeals for the Sixth and Eighth Circuit. Teach a weekly seminar on federal defense practice, litigation, and lawyering skills.

• <u>Decarceration and Compassionate Release</u>: In Spring 2019, the Clinic began handling post-conviction sentencing review cases under the First Step Act of 2018. Those cases include crack-cocaine sentencing reductions (Section 404) and compassionate-release matters (Section 603). Representations in those cases includes individuals sentenced in the federal district courts in Iowa, the Eastern District of Kentucky, the Northern District of Texas, and the Middle District of Florida. In addition to direct representation, students track and graph daily COVID-19 infection rates in federal facilities, create design and <u>visual advocacy projects</u> highlighting COVID-19 deaths in prison, and assist in the drafting of legal obituaries for the more than 260 people who have died in federal Bureau of Prisons custody.

# Voting & Citizenship Rights Restoration Clinic (VRRC) (Fall 2018 – Summer 2020)

Co-supervise law students in their representation of over 60 individuals with prior convictions seeking to understand the voting- and citizenship-rights restoration process in Iowa and assist those individuals with rights-restoration applications. Teach a companion classes focusing on the basics of brief-services representation and substantive law. Conducted clinics throughout Iowa: Linn (10/2018, 7/2019); Polk (3/2019); Blackhawk (3/2019); Woodbury (5/2019); Scott (10/2019). Worked with 1L students through the Citizen Lawyer Program (Spring 2019-20).
