

MANAGER’S AMENDMENT TO H.R. 3300
OFFERED BY MR. SHUSTER OF PENNSYLVANIA

Page 7, after line 24, insert the following (and re-designate subsequent subparagraphs accordingly):

- 1 (D) The Director of the Office of Dis-
2 ability Integration and Coordination of the Fed-
3 eral Emergency Management Agency.

Page 8, line 23, Strike “cellular” and insert “commercial mobile radio service”.

Page 9, line 16, after “shall meet” insert “, at least annually,”.

Page 13, line 5, strike “and” at the end.

Page 13, line 11, strike the period at the end and insert “; and”.

Page 13, after line 11, insert the following:

- 4 (viii) promotes the participation of
5 representatives from traditionally under-
6 served and underrepresented communities,
7 to ensure that alerts and warnings reach
8 such populations.

Page 14, line 2, strike “3” and insert “6”.

At the end of the bill, add the following:

1 **SEC. ____ . ELIGIBILITY OF PUBLIC BROADCASTING FACILI-**
2 **TIES FOR CERTAIN DISASTER ASSISTANCE.**

3 (a) PRIVATE NONPROFIT FACILITY DEFINED.—Sec-
4 tion 102(11)(B) of the Robert T. Stafford Disaster Relief
5 and Emergency Assistance Act (42 U.S.C. 5122(11)(B))
6 is amended by inserting “public broadcasting facilities,”
7 after “workshops,”.

8 (b) CRITICAL SERVICES DEFINED.—Section
9 406(a)(3)(B) of such Act (42 U.S.C. 5172(a)(3)(B)) is
10 amended by striking “communications,” and inserting
11 “communications (including public broadcasting),”.

12 **SEC. ____ . REVIEW AND REPORT REGARDING THE ELIGI-**
13 **BILITY OF CERTAIN HOUSING ENTITIES TO**
14 **RECEIVE DISASTER ASSISTANCE.**

15 (a) IN GENERAL.—Not later than 90 days after the
16 date of enactment of this Act, the Administrator of the
17 Federal Emergency Management Agency (FEMA) shall,
18 using funds from FEMA’s management and expenses ac-
19 count, complete a review of, and submit to the Committee
20 on Transportation and Infrastructure of the House of
21 Representatives a report describing, options, both com-
22 mercial and governmental, available to housing coopera-

1 tives and condominium associations to assist in repairing
2 and rebuilding common areas following a major disaster.

3 (b) REPORT SPECIFICS.—The report shall include—

4 (1) a description of the current eligibility of
5 housing cooperative and condominium association
6 owners and residents to receive disaster relief funds
7 under FEMA disaster relief programs;

8 (2) a description of the availability of individual
9 assistance for such owners and residents to help
10 cover the costs of repairing disaster-related damage
11 to common areas, including any details of instances
12 in the past 10 years in which cooperative or condo-
13 minium owners or residences received such assist-
14 ance to help cover costs and assessments for repairs
15 to common areas;

16 (3) a description of commercial options and re-
17 quirements, including insurance coverage, that may
18 be applicable; and

19 (4) a discussion of options, including any pro-
20 posed changes to law, for addressing any gaps iden-
21 tified in available assistance to address disaster-re-
22 lated damage to common areas.

1 **SEC. ____ . PHYSICAL TESTING STANDARDS FOR ELECTRIC**
2 **UTILITY FACILITIES.**

3 (a) **STUDY.**—The Administrator of the Federal
4 Emergency Management Agency shall conduct a study to
5 compare the differences between—

6 (1) the physical testing standards that the Ad-
7 ministrator applies with respect to electric utility fa-
8 cilities as a condition for Federal assistance; and

9 (2) the physical testing standards that are ap-
10 plied to electric utility facilities by the electric utili-
11 ties industry and by the Rural Utilities Service of
12 the Department of Agriculture.

13 (b) **REPORT.**—Not later than 180 days after the date
14 of enactment of this Act, the Administrator shall submit
15 to the Committee on Transportation and Infrastructure
16 of the House of Representatives and the Committee on
17 Homeland Security and Governmental Affairs Committee
18 of the Senate a report on the results of the study.

19 (c) **FUNDING.**—The Administrator shall carry out
20 this section using funds available to the Administrator for
21 management and expenses.
